"No Parking on the south side of Parklands Drive commencing at a point 22m east of the south east intersection of Parklands Drive and Cunningham Road and continuing for 16m"

And

"No Parking on the south side of Parklands Drive commencing at a point 67m east of the south east intersection of Parklands Drive and Cunningham Road and continuing for 12m" And

"No Parking on the south side of Parklands Drive commencing at a point 107m east of the south east intersection of Parklands Drive and Cunningham Road and continuing for 7m"




