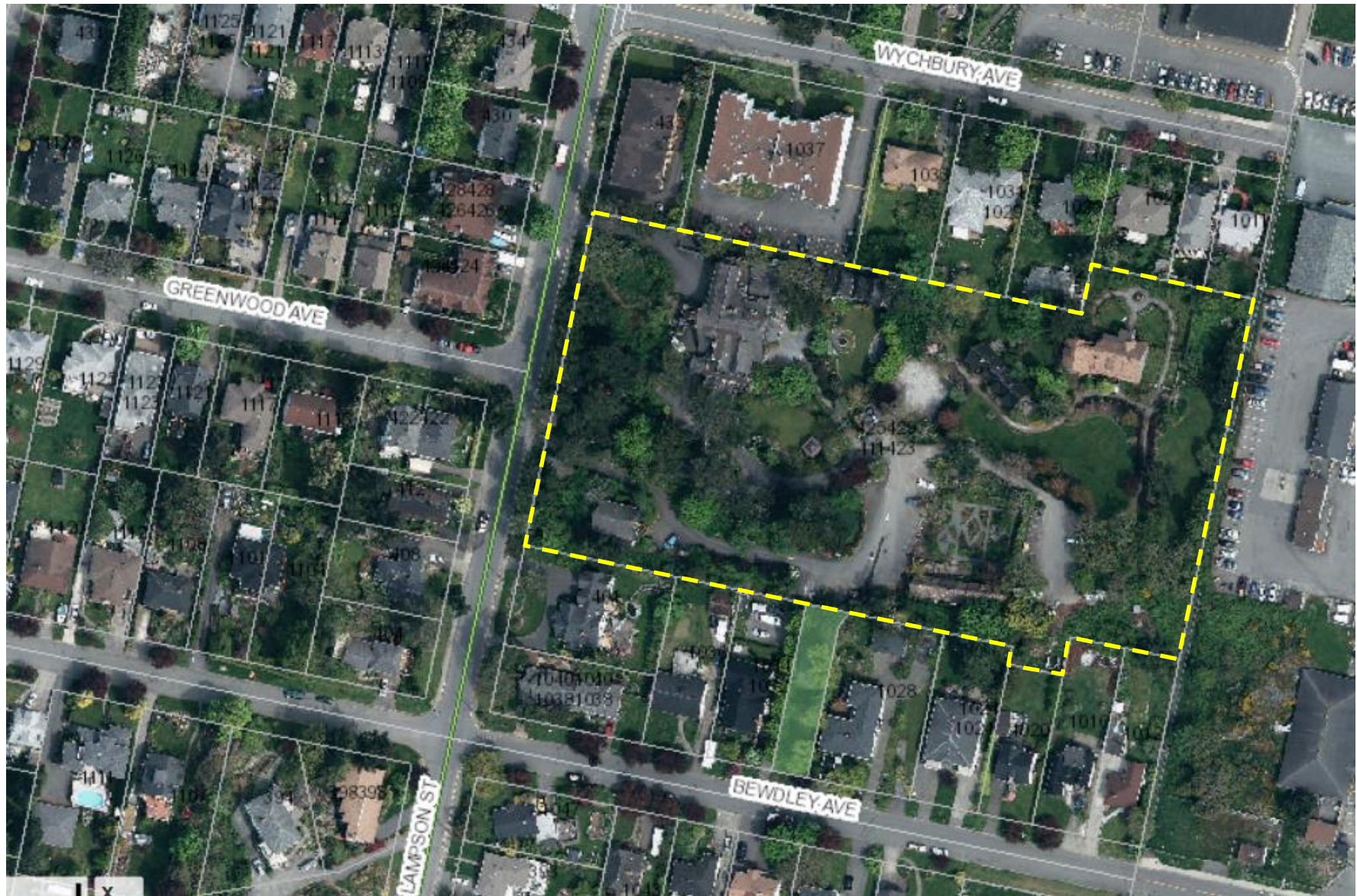


**SUBJECT PROPERTY MAP**

### HERITAGE ALTERATION PERMIT WITH VARIANCE NOTICE

An application for a Heritage Alteration Permit with Variance has been received from the registered owner of 429 Lampson Street.

#### **Purpose of the Application:**

The property owner is proposing a renovation to revitalize the historic English Inn (Manor house). The renovation includes the removal of a two small ancillary exterior stairs at the front of the building and the additions of new exterior stairs and a small infill below an existing upper level room at the rear of the building, extending into the rear gardens which will increase the footprint of the Manor house slightly. The property's development is governed by Comprehensive Development District No. 84 [CD No. 84] of Esquimalt Zoning Bylaw 1992, No. 2050; therefore the following variance to siting is being requested.

#### **Zoning Bylaw 1992, No. 2050, Section 67.71 B. Site A (7)(a) Siting Requirements -**

**Principal Building** – A variance to the permitted perimeter of the principal building as shown in the Land Surveyor's Certificate prepared by McElhanney Consulting Services, stamped 'Received September 9, 2013'; to allow the addition of a 'new main level terrace and exterior grand stair', a 'new lower level infill below an existing upper level addition' at the east side of the building and the removal of two exterior 'existing stairs and doors' at the front (west side) of the building; as detailed on Schedule A [the Site Plan - Sheet A1.61] prepared by Merrick Architecture and stamped 'Received September 18, 2017'.
