2. This Development Variance Permit regulates the development of lands by varying the provisions of Subdivision and Development Servicing Bylaw No. 3128, 2023 as follows:

- By not requiring at time of Building Permit that the owner is required to adhere to Subdivision and Development Servicing Bylaw No. 3128, 2023, Section 5.(5)(a):

The Owner of Any Parcels that are the subject of any proposal for Subdivision or Development must provide each Parcel with Highway Works and Services including without limitation, sidewalks, cycling facilities, street lighting, transit shelter, pedestrian crosswalk, traffic sign or signal, street furniture and public improvements, transit bays, boulevards, highway median or boulevard planting.

3. Approval of this Development Variance Permit is issued in accordance with the following:
 - Schedule A: Site Plan – Invision Developments – A101 Stamped “Received Sept 17 2025”
4. The terms, conditions and covenants contained herein shall enure to the benefit of and be binding upon the Owners, their executors, heirs or administrators, successors and assigns as the case may be or their successors to title in the lands.

5. This Permit lapses two (2) years after the date it is issued if the holder of the Permit does not substantially start any construction with respect to which the Permit was issued.
6. For the purposes of this Development Variance Permit, the holder of the Permit shall be the owner(s) of the lands.
