Dear Members of Esquimalt Council,

I'm writing on behalf of the Justice Team of Esquimalt United Church, a group committed to social, economic, and environmental justice. We are very concerned – and we think you probably are too – about the loss of biodiversity in our province. Of all the Canadian provinces and territories, BC is home to the richest diversity of vascular plants, mosses, mammals, butterflies and breeding birds. Many of the species in British Columbia are at risk of extinction. According to the Nature Trust of BC, of the 3,808 native species in BC for which conservation status has been assessed, 43% are considered "of provincial biodiversity concern."[1]

And, according to the Government of Canada: "Biological diversity is vital to maintaining life on Earth and to ensuring a clean, safe and sustainable environment." [2]

The good news is that it's not too late to turn the tide. We are still able to protect the health of natural ecosystems, restore habitat, remove invasive species, reduce pollution. Recently the Esquimalt United Church Justice Team learned of a campaign being spearheaded by the Sierra Club of BC, involving concerned citizens all over BC going to their municipal councils to ask for support for the attached resolution. This resolution will be moved at the next meeting of the Union of BC Municipalities (UBCM) in September. And the more support it receives, the more chance that it will pass and encourage the BC government to support biodiversity at a municipal level, including the creation of a fund for municipal biodiversity projects. We feel this would be a benefit for us all.

We therefore urge you to support this motion when it comes before council.
