Holly Courtright, Esquimalt Chamber of Commerce, spoke in support of maintaining membership in the South Island Prosperity Partnership, exploring opportunities through the Municipal & Regional District Tax Program, and planning for future Economic Development Action Plans.

The Fire Chief introduced the report and responded to questions from Council.

Council comments included the following:

- Staff's work on this initiative is appreciated.

- Grant funding opportunities are supportable.

Moved by Councillor Cavens, seconded by Councillor Brame: That Council approve the acceptance of funding under the 2025 FireSmart Community Funding & Supports Program in the amount of \$138,003.65, and that the Mayor and Corporate Officer be authorized to execute any required grant agreements related to the successful application, as outlined in Staff Report No. FIRE-25-009. Carried Unanimously.

The Manager of Economic Development introduced the report and responded to questions from Council.

Council comments included the following:

- Receiving an update from the South Island Prosperity Partnership (SIPP) will allow the funding decision to be made within the context of the annual budget process.

Moved by Councillor Helliwell, seconded by Councillor Morrison: That Council receive the review of the Township's membership in the South Island Prosperity Partnership and the update on the 2023-2025 Economic Development Action Plan for information, and direct that a decision on renewing South Island Prosperity Partnership (SIPP) membership for five years be considered during the 2026 budget process following receipt of SIPP's Fall Rising Economy 2030 Plan. Carried Unanimously.

The Director of Engineering and Public Works introduced the report, and responded to questions from Council..

Moved by Councillor Brame, seconded by Councillor Armour: That Council direct staff to not pursue further exploration of Integrated Resource Management (IRM) in the Township and instead support a regional approach to IRM led by the CRD, as described in Staff Report No. EPW-25-016.

Moved by Mayor Desjardins, seconded by Councillor Cavens: That the main motion be amended to include "at this time" after the word "management" and before "in the."

Council comments included the following:

- Significant work has gone into researching Integrated Resource Management (IRM), and could be useful in the future given that waste

management pressures are rising.

- A decision to not proceed with IRM can be revisited in the future without the amendment.

- Adjusting the wording could provide reassurance to community members who supported the initiative that Council remains open to revisiting this opportunity in the future.

The amendment to the Main Motion was put and Carried Unanimously.
