1) [24-414](#) 2025 Permissive Tax Exemption Applications

The Director of Financial Services provided an overview of the applicants before the Committee.

Committee Discussion:

- Exemptions granted in previous years and the length of the exemptions;
- The amount of foregone revenue for each application;
- Standard practice regarding granting permissive tax exemptions to another municipal government;
- Primary purposes of the applicants and the benefit to the Township that they offer;

- The scope of statutory tax exemptions applied to places of worship by BC Assessment;
- Precedent for granting permissive tax exemptions to places of worship, beyond the statutory exemptions;
- Distinction between different classes of properties and their merits to the community; and
- Philosophy or methodology behind granting permissive tax exemptions.

| Our Lady Queen of Peace Parish: | 75% for 2025 and 2026, and 50% 2027; |
| Van Hanh Buddhist Society: | 75% for 2025 and 2026 for the Class 6 & 8, and 50% for 2027 for Class 6 & 8, and no exemption for Class 1; |
| Aga Khan Foundation Canada: | 75% for 2025 and 2026, and 50% for 2027. |
