#### 5. PUBLIC INPUT ON ITEMS 6 AND 7

There was no public input.

#### 6. PRESENTATIONS AND DELEGATIONS

1) <u>25-278</u> Delegation - Katie Oppen - Indexed Property Taxes

Katie Oppen addressed Committee of the Whole on indexed property taxes and recommended that Council consider bringing forward a resolution to the Union of British Columbia Municipalities (UBCM) to petition the Provincial Government to grant local governments the ability to implement an indexed property tax system.

### 7. STAFF REPORTS

1) <u>25-384</u> Levels of Service Discussion, Staff Report No. ADM-25-059

The Chief Administrative Officer introduced the Levels of Service discussion. Department Directors provided presentations on levels of service and responded to questions from Committee of the Whole.

Committee of the Whole comments included the following:

- Regular review of Fees and Charges was suggested to ensure they remain current;
- Interest was expressed in additional information on the consultant's review of the Engineering and Public Works Department;
- An anonymous survey of development applicants to assess levels of service was proposed;
- A review of the cost recovery philosophy in Development Services was recommended to confirm the appropriateness of the current approach;
- Tracking staff hours was identified as a potential way to inform cost recovery fees and charges by establishing application and housing type averages.

The meeting went into recess at 7:59 PM.

The meeting was reconvened at 8:04 PM.

Committee of the Whole comments (continued):

- A Finance Department organizational chart was requested;
- Additional information was requested regarding Emergency Management, Bylaw Enforcement, and Parking;
- Council requested an overview of the Director of Strategic Initiatives' portfolios, including the department's current state and future direction;
- A deeper review of Development Services projects was requested, including which can be completed this term and how additional full time employees (FTEs) or resources could affect outcomes;
- A review of the Council Priority Plan was requested to assess progress and prepare for a transition to the next Council term;
- A summary of consultant use and spending across departments was requested, to be compared with proposed FTE additions for potential in-house alternatives:
- A third-party review of the Development Services Department was suggested;
- It was noted that Level of Service reviews should consider both efficiency and cost savings;
- More information on Human Resources and Community Relations was requested;
- Interest was expressed in better understanding how increased revenue, offsets, and staff overtime are managed.

There was no public comment.
