

CORPORATION OF THE TOWNSHIP OF ESQUIMALT

BYLAW NO. 3134

A Bylaw to amend Bylaw No. 2898, cited as the
"Streets and Traffic Regulation Bylaw, 2017, No. 2898"

The Council of the Corporation of the Township of Esquimalt, in open meeting assembled, enacts as follows:

1. This Bylaw may be cited as the "Streets and Traffic Regulation Bylaw, 2017, No. 2898, Amendment Bylaw, 2024, No. 3134."
2. That Bylaw No. 2898, cited as the "Streets and Traffic Regulation Bylaw, 2017, No. 2898" be amended as follows:

(1) By deleting and replacing the definition of "crosswalk" in Section 2 (2) with:

"crosswalk" shall mean:

- a) The portion of the roadway ordinarily included within the prolongation of the lateral lines of sidewalks at intersections and any portion of a highway indicated for pedestrian crossing by lines or other markings;
- b) the portion of a highway at an intersection that is included within the connection of the lateral lines of the sidewalks on the opposite sides of the highway, or within the extension of the lateral lines of the sidewalk on one side of the highway, measured from the curbs, or in the absence of curbs, from the edges of the roadway; or
- c) the portion of the roadway at an intersection or elsewhere that is designated for bicycle crossing by signs or elephant feet markings or other markings on the road surface.

(2) By inserting in alphabetical order in Section 2 (2) the following definitions:

"elephant feet markings" shall mean a series of white painted squares that delineate a crosswalk where cycling is permitted.

"multi-use pathway" shall mean a highway or portion thereof reserved for use by pedestrians, bicycle and other non-motorized conveyances, and designated as such by a traffic control device.

(3) By deleting and replacing Section 13 (3) with the following:

(3) The following streets or portions shall have a maximum speed of 30 Km/hr:

- on Admirals Road from Esquimalt Road to Bewdley Avenue;
- on Agnes Street;

(4) By deleting and replacing Section 13 (4) with the following:

(4) The following streets or portions shall have a maximum speed of 40 Km/hr:

- On Admirals Road from Esquimalt Road to Maplebank Road;
- On Colville Road from Admirals Road to Tillicum Road;
- On Craigflower Road from Dominion Road to Admirals Road;
- On Esquimalt Road from Canteen Road to Dominion Road;
- On Lampson Street between Transfer Street and Esquimalt Road;
- On Tillicum Road from Colville Road to northern limits of Esquimalt near middle of Gorge Bridge; and
- On Transfer Street.

- (5) By deleting and replacing Section 39 (1) (a) with the following:
 - (a) on a sidewalk, boulevard or multi-use pathway;
- (6) By deleting and replacing Section 130 (2) (a) with the following:
 - (a) must not ride a bicycle in a marked crosswalk unless it is also marked with elephant's feet markings on one or both sides of the crosswalk, or such movement is otherwise permitted by a traffic control device or authorized to do so by a Bylaw. Within the Township the following intersection crosswalks a person operating a bicycle can ride within a crosswalk without elephant's feet:
 - Admirals Road / Colville Road / E&N Railway
- (7) By deleting the word "and" at the end of the sentence in Section 130 (2) (f)
- (8) By deleting and replacing the period at the end of the sentence in Section 130 (2) (g) with a semi colon and then the word "and".
- (9) By adding the following as new Section 130 (2)(h):
 - (h) must yield the right of way to pedestrians who are entering into, walking in, or exiting from the crosswalk.
- (10) By adding the following as new Section 131(6):
 - (6) Subsection (2) does not apply if:
 - (a) notwithstanding section 183(2)(a) of the *Motor Vehicle Act*, riding a bicycle on a sidewalk or multi-use pathway is permitted by a traffic control device.
