**NOW THEREFORE** in the exercise of the powers given in the said By-law, **I DO HEREBY ORDER THAT**:



"One Hour Parking Only Monday – Friday 7:00am – 5:00pm" signage be installed on the east side of Park Place commencing 53.5m from the intersection of Carlisle Avenue and continuing north for 21m. Traffic Order 1330 to be rescinded.
