The Victoria Jazz Society's Governance Framework formally defines the roles and structure of its Board and Management. This framework was adapted from materials from the National Centre for Non-profit Boards. Overall, the Board of Directors is to: be accountable to the public, participate in the development of the VJS, oversee and support the Executive/Artistic Director, ensure administrative continuity, and secure the community's support. The individual roles of the Board's Officers and Chairs are Board President, Vice President, Secretary, Treasurer, and Director. There are finance, membership, sponsorship, and governance committees on the Board. Members of the Board are free from any conflicts of interest and are independent from the VJS staff. To ensure that the Board is qualified for its responsibilities, candidates are considered based on their experience with finance, fundraising, corporate sponsorship,

To ensure that the Board is qualified for its responsibilities, candidates are considered based on their experience with finance, fundraising, corporate sponsorship, law, event coordination, and non-profit operations. Once a candidate is vetted and elected to the Board at the Annual General Meeting, appointments are two-year, renewable terms.

Management roles and a staff hierarchy are also defined in the Governance Framework. The Executive/Artistic Director reports to the Board and is responsible for VJS leadership, management, and programming. The Operations Manager reports to the Executive/Artistic Director and supports him in the implementation of management and programming. Other VJS staff report to the Executive Director and/or the Operations Manager.

The VJS staff has a strong base of expertise within the field of arts presentation. The founder of JazzFest and Blues Bash has acted as Executive Producer/Artistic Director for all VJS programming for over 30 years. The most senior staff member is the current Operations Manager, who has been with the VJS for 21 years. The Communications Coordinator is the next most senior staff member with four years at the VJS and the Operations Assistant has been with us for three years. Together, the four core VJS staff has over 65 years of cumulative experience executing the VJS's programming in shows in the largest theatres in Victoria to the smallest impromptu pop-up shows on a sidewalk. Their combined expertise is what allows the society to function professionally and efficiently and is instrumental in mentoring new seasonal staff members. Seasonal staff are usually co-op students from UVic or Camosun College who are hired for the festival season to supplement the core staff. Other staff are contracted for specific duties pertaining to the production of the festivals.

5. What is your organization's history of providing benefit to the residents of Esquimalt?

The Victoria Jazz Society has no recent history of presenting in Esquimalt; however, in the past the VJS utilized Esquimalt High School Theatre for year-round presentations. For instance, the VJS presented the Bill Charlap Trio at the Esquimalt High School Theatre in 2008, and the VJS facilitated a workshop hosted by Bill Charlap at this venue at no charge to students. In addition, our outreach initiative, "Jazz in Schools" (2009-2018), was presented to music students at Esquimalt High School. This combination of workshop and question and answer period was performed at the school by the Leon Nagasaki Quartet. As well, the VJS included Esquimalt High School jazz band students in "Student Performance Day" at the TD Victoria International JazzFest 13 times between 1996 and 2010. For this performance, students were given professional production services on a professional outdoor stage where they performed for an honorarium to maximum capacity audiences.

6. What is your organization's role or niche in the community? What makes it different from other similar organizations?

The TD Victoria International Jazz Fest (formerly known as JazzFest International) is the longest-running professional music festival on Vancouver Island. This iconic event, the "grandfather" of music festivals serving audiences on Vancouver Island and beyond, has evolved from a four-day festival to a vibrant, 10-day celebration of jazz and its associated genres located in the heart of Victoria. Attracting over 40,000 people every year, TD JazzFest is an integral part of the local, national, and international jazz scene, and the highlight of the VJS's annual presentations. Firstly, the VJS contributes to the development of live jazz on a local level. VJS programs remain at the core of Victoria's music scene. TD JazzFest is the longest running professional music festival and Blues Bash is the longest running blues festival on Vancouver Island. Both festivals have a devoted fan-base; however, due to both festivals have a devoted fan-base; however, due to both festivals babel as a Canadian cultural hot spot, attracting fourists from all over the world, and increasing visibility for hotels, restaurants, and other local businesses in addition to our audiences. As well, an imperative aspect of the VJS's artistic vision is to efficiently provide work and other support to local musiclars/bands. All artists are guaranteed a performance fee, whether their concert is delivered "free-to-the-public," virtually, or its cketed. Another incredibly valuable experience made possible by the VJS is hiring local musicians to open for critically acclaimed festival headliners, whenever appropriate. The VJS cultivates lasting bonds with artists/bands across BC. Secondly, the VJS continues with its proven record of community involvement and impact by building relationships with local cultural organizations when it is presenting artists/bands that culturally align with those organizations. Our eclectic programming will continue to appeal to different members of our community, whether through the cultural music we provide to different lo

7. How is your organization moving towards financial self-sufficiency?

How is your organization moving towards financial self-sufficiency?
The Victoria Jazz Society is committed to fiscal responsibility and continues to prioritize the development of a sustainable financial model. This is to ensure its future viability, especially within a relatively unstable economy because of post-pandemic restrictions and increased cost of living. The VJS's primary financial challenge is developing reliable funding sources. As mentioned, new sponsors and reliable funding sources are sought annually by the VJS for both of its festivals and year-round program. Ticket revenue is a large percentage (70 – 80%) of earned revenue for the VJS, and each year the society aspires to increase ticket sale revenue. It is the hope of the VJS that with the return to live music in front of live audiences, we will once again be able to count on ticket sales, merchandise sales, and concession sales as a major revenue stream.

The VIS will continue to increase attendance at its presentations frough marketing and audirence development.

Another important funding source for the festivals is corporate sponsorship. The VJS hopes our very dedicated base of long-time sponsors will return for the 2022 festivals and beyond. The VJS is optimistic about its ability to gain new sponsors in 2022 with a more proactive push from the VJS Board Sponsorship Committee.

The VJS does not currently carry a deficit and has an internally restricted Working Capital Reserve Fund. The purpose of the Reserve is to cover potential future operating deficits (shortfalls in corporate funding and/or government funds, lower than anticipated ticket, merchandise, or concession sales) to assist in the long-term financial stability of the Society.

Annually, TD Victoria International JazzFest comprises of ticketed evening performances at theatres, nightclubs, our outdoor stages, and restaurants. As well, the festival has a significant "free to attend" component which allows music lovers from all walks of life and income levels to attend performances on the outdoor stage and at its educational workshop/clinics.

For this project, TD JazzFest would like to expand its festival in 2022 to include Bullen Park (Fleid) in Esquimati as an outdoor venue for both "free to steed" daytime performances and ticketed evening performances. The dates for these performances will be Friday, July 1, 3 sturday, July 2 and Sunday, July 2, 2022. These "There to attend" performances on July 1 - 3 will begin at noon and end at 8pm on July 1 and 5pm on July 2 and 3. Ticketed evening performances will take place on Saturday and Sunday, July 2 and 3 with gates opening at 8pm on each night and performances beginning at 8:30pm and ending at 10pm on those two nights. Optionally, we would like to present ticketed performances on Sunday, June 26 and Thursday, June 30. This option would be contingent on the need for an outdoor stage to accommodate appropriate acts being available on these two evenings.

Bullen Park will make a perfect location for our outdoor festival site for both "free to attend" and tickets performances. This festival site will include an "instrument Petting Zoo" as well as face painting and other family activities, if possible, a front of house tent, and a limited number of food vendors. The VJS would like to hold the "free to attend" performances in Bullen Park as it would broaden the footprint of our festival. The direct introduction of the festival into the township of Equipmat will draw new audiences of all ages for the music we present. In addition, the flat, grassy field of Bullen Park will become a more attractive venue and conductive to drawing a larger audience, in comparison to our previous city-situated outdoor venue. Bullen Park appeals to the general public as a more family friendly location, more comfortable, and more accessible. As with all our VJS presentations, the on-stage sound and lights will be provided by local professionals for both local and buring artists performing at Bullen Park.

The VJS plans to enlist in the help of Esquimalt High School Students to volunteer at the Bullen Park location for TD JazzFest. This could include a VJS representative visiting the school and explaining the process of signing up to be a volunteer and answering any questions. This helps the high school students of Exquinal fulfill their graduation volunteer requirements while providing a fun way for them to give back to the community.

Over a three-day period (Juty 1, 2, and 3), 71% of the music will be presented "free to attend" therefore making the music financially accessible to all wishing to attend. JazzFest prides itself on being inclusive and welcome all ages (where applicable), races, ethnicities, and genders to our festival. TD JazzFest programs BIPOC and LGBTQ+ artists whenever possible to foster a more inclusive atmosphere and to appeal to the widest range of

audiences.
The presentation of TD JazzFest in Bullen Park will draw both Greater Victoria audiences as well as tourists to Esquimalt, which will in turn support the economic development of surrounding businesses, increasing the ncy of the town and Bullen Park.

The stage, ents and some fencing will be left in place until Thursday, June 30 when the site will open again to the public.

How will your organization measure whether the program or event was a success?

The success of our outdoor site in Bullen Park will be measured by audience attendance at "free to attend" events and by ticket sales for ticketed evening events. As well, TD JazzFest creates an annual survey for the festival which provides the Victoria Jazz Society with valuable statistics from a large sample pool. Usually, the VJS receives approximately 700 completed surveys each TD JazzFest. The VJS would be open to making a Bullen Park-specific survey and welcome any questions that the Township of Esquimalt would like to add for their own information, thus collaborating on a restructuring of the survey for this venue.

10. What is the minimum level of funding required for the program, project or event to occur? What would be the impacts if you received less than your full request?

As Bullen Park would be a new venue for JazzFest in 2022, it is imperative that the majority of the funding requested from the Township of Esquimalt is received for next year's festival. If the VJS receives less than its full request, the impacts would be that all artists presented would need to be lower profile acts due to less funds available to put towards artist fees, thus risking a decrease in audience interest and therefore attendance.

A special issue that may affect expenses or revenues in the projected year is the ongoing COVID-19 pandemic and its associated regulations which have continued to affect the VJS's ability to present live music to live audiences since 2020. It is hoped that with the regulations being minimized, we will be able to move forward in the future with regular programming in 2022 and beyond. The pandemic and its many variants do, however, remain an unknown factor for the foreseeable future.

The Victoria Jazz Society will allocate a designated percentage of the title sponsorship from TD to this project, as well as percentages of the following government-funded grants:

19. How many volunteer staff do you utilize and what are the total volunteer hours?

Approximately 250 volunteers are utilized annually to present the TD Victoria International JazzFest. Across the ten-day festival, our volunteers put in an accumulated 3,750 hours, and many volunteers choose to do more than their required three shifts. The majority of these volunteers help at our outdoor sites. We anticipate that by establishing Bullen Park, we would welcome Esquimalt residents to volunteer and become involved in our festival.

20. Could the program, project or event occur without volunteer support? Why or why not?

With only four core staff and one or two seasonal employees for the festival season, the VJS would not be able to produce JazzFest each year. Our volunteers are the heart and soul of our festival!

21. Please describe any significant established partnerships with other community groups

The VJS has built relationships with local cultural organizations when it is presenting artists/bands that culturally align with those organizations, such as the local Indigenous, Latin, Greek, African, Caribbean, French, Italian, Japanese and Jewish organizations. This encourages links between the cultural communities represented by the organizations and the artists being presented.

The VJS is also longstanding member of numerous local organizations, including Greater Victoria Chamber of Commerce and Tourism Victoria, and it is a founding member of Jazz Festivals Canada. These partnerships reaffirm ties between the arts and business communities and open doors for national and international artists to perform in Victoria.
