CORPORATION OF THE TOWNSHIP OF ESQUIMALT

BYLAW NO. 2872

A Bylaw for the levying of rates for Municipal, Regional District and Regional Hospital District purposes for the year 2016.

THE MUNICIPAL COUNCIL OF THE CORPORATION OF THE TOWNSHIP OF ESQUIMALT, in open meeting assembled, enacts as follows:

- 1. This Bylaw may be cited as the "TAX RATES BYLAW, 2016, NO. 2872".
- 2. The following rates are hereby imposed and levied for the year 2016:
 - (a) For all lawful purposes of the municipality on the assessed value of land and improvements taxable for general municipal purposes, rates appearing in column "1" of Schedule "A" attached hereto and forming a part hereof.
 - (b) For purposes of the Capital Regional District on the assessed value of land and improvements taxable for general municipal purposes, rates appearing in column "2" of Schedule "A" attached hereto and forming a part hereof.
 - (c) For purposes of the Capital Regional Hospital District on the assessed value of land and improvements taxable for regional hospital district purposes, rates appearing in column "3" of Schedule "A" attached hereto and forming a part hereof.
- 3. The minimum amount of taxation upon a parcel of real property shall be One Dollar (\$1.00).
- 4. The aforesaid rates and taxes shall be considered to have been imposed on and from January 1, 2016 and shall be due and payable at the office of the Collector of Taxes of the Corporation of the Township of Esquimalt, in the Province of British Columbia, by July 4, 2016 or mailed within Canada with a legible postmark dated June 23, 2016 or prior; or paid at a financial institution in Canada on or before July 4, 2016.
