1. CALL TO ORDER

Councillor Armour as Acting Mayor called the Regular meeting of Council to order at 7:00 PM.

Mark Eraut, non resident, and representative of town centre businesses thanked Council for the Committee of the Whole recommendation regarding the bike lane project on Esquimalt Road and requested involvement in the discussion going forward.

7. STAFF REPORTS

1) <u>24-254</u> Janitorial Services for Municipal Facilities - Contract Award, Staff Report No. EPW-24-012

The Director of Engineering and Public Works introduced the report and responded to questions from Council.

Moved by Councillor Cavens, seconded by Councillor Rotchford: That Council award the contract for Janitorial Services for Municipal Facilities to SkyBlue Services Corporation for a total cost of \$224,334 (excluding GST) for a two-year term, with an option to extend the contract for an additional two one-year terms, as described in Staff Report EPW-24-012. Carried Unanimously.
