### 1. CALL TO ORDER

Mayor Desjardins called the Regular Committee of the Whole meeting to order at 7:02 PM.

Mayor Desjardins acknowledged with respect that we are within the Traditional Territories of the Esquimalt and Songhees First Nations.

### 3. APPROVAL OF THE AGENDA

Moved by Councillor Burton-Krahn, seconded by Councillor Liberchuk: That the agenda be approved as amended with the inclusion of the late item. Carried Unanimously.

### 5. PRESENTATIONS

2) 17-389 Badging Ceremony for Bodi, Vic PD Police Service Dog Mayor Desjardins awarded Cst. Eric Lequesne, PSD Bodi's partner, his official badge as an explosives detection dog with the VicPD K9 team. Bodi received his name as part of a Victoria and Esquimalt elementary school naming contest and stands for "Bomb Odour Detected Immediately". Bodi's badging denotes that he has passed his training and is ready for full deployment.

1) <u>17-377</u> Victoria Police Department Quarterly Report, Framework Agreement, Chief Manak

Chief Del Manak provided an overview of the Victoria Police Department Framework Agreement second quarterly report, presented a PowerPoint presentation and responded to questions from Council. Community engagement events included Rainbow Kitchen volunteer appreciation dinner and Esquimalt block party. Facebook and Twitter continued as a community communication tool with 42 media releases, 760 tweets and a further 600 bikes were registered with the Victoria PD bike registry crime prevention initiative.

Inspector Jamie Pearce responded to guestions from Council.

Council comments included (Staff response in italics):

- \* How do you determine response times to Priority 1 and 2 calls? There is no industry standard; however, the times recorded may reflect a margin of error, as officers are actively engaged with the incident therefore delayed in updating technology, that they have arrived on the scene.
- \* Abandoned 911 calls and options to reduce the volume of calls and options to partner with phone providers.
- \* Graffiti increase in the community.

- \* Homeless camper concerns overlapping from Victoria to Esquimalt.
- \* Reserve units training and volunteer retention.

# **Community Safety Services**

Councillor Hundleby encouraged participation on September 30th for Orange Shirt Day: Every Child Matters, acknowledging the time of year when First Nations youth were taken from their homes to attend residential schools. Councillor Burton-Krahn advised that she will be bringing forward a Notice of Motion in the near future, and further consideration be postponed to a future Committee of the Whole meeting for discussion following receipt of the Notice of Motion.
