- \* Stakeholder groups including First Nations, TCAC, DND, Esquimalt Chamber of Esquimalt, Esquimalt Farmers Market, Esquimalt Neighbourhood House Society and internal/ external Committee members
- \* Different events require different communication strategies use social media, email and website
- \* Liaise with other social media community groups for a greater geographical area of advertising events
- \* Connect with schools to connect with youth and young families
- \* Seeking a greater engagement level that aniticipated by the consultant and would consider increasing timelines to accommodate
- \* Ensure opportuities for information to be available for the public to follow the timeline and process
- \* Process should be a fun and positive platform for all the community to participate
- \* Define the timelines and benchmarks for completion to ensure funding received
- \* Advance notice to the public outlining event dates
- \* Funding options for media communication
- \* Sensitivity to Heritage engagement
