I'd like to submit my negative thoughts about the proposed location for the cannabis store on esquimalt rd.

My son goes to preschool at the apple tree, very close to the proposed location. And we frequent the neighbourhood house for play groups, again close by. I do not like the thought of a cannabis store this close to places my three year old and three month old go on a daily basis. I understand smoking marijuana is legal but the smell is disgusting and not suitable for children to be near.

I've read that it's not legal for a cannabis store to operate within 1000 feet of a preschool in Oregon and I have not determined how close it is to the apple tree, but it's not far off. I hope that American legality is considered for this location as well. I can't find the bylaw for bc but I hope it's similar.

My biggest concern is that people continue to smoke regular cigarettes at the parks we frequent in esquimalt, despite the signs. A cannabis store will inevitably mean people will smoke or use marijuana near it. And I don't want that near my children. It's not fair to them.

I also don't think it's fair to the preschool as I, and others, may choose to pull kids from the preschool due to the location of the cannabis store.

Please keep esquimalts youngest kids in mind and have a different location chosen for the store.
