VURD FEB2020 Gathering EVENT PLAN

Background

On March 29, 2018, representatives from urban Indigenous organizations, government and community gathered at the Victoria Native Friendship Centre (VNFC) to engage in a dialogue about reconciliation in Victoria and area. This group now acts as a Steering Committee for the Victoria Urban Reconciliation Dialogue (VURD), an initiative hosted by VNFC. The process reflects a sectoral and grassroots approach where the ultimate accountability is to the urban Indigenous community and their allies.

The VURD Steering Committee meets regularly and has hosted two Advisory Panel Gatherings, bringing together 40 people in November 2018 and 85 people in February 2019, from various organizations and relevant sectors. VURD also has a Working Group which acts as the secretariat and project office. More information can be found at www.TheDialogueVictoria.ca, or email TheDialogue@vnfc.ca.



Purpose of VURD Feb2020 Gathering

Four main purposes have been identified for the Gathering:

- 1. **Grow the Circle**: Build and strengthen relationships through networking and shared cultural and educational experience designed to connect 300 people.
- 2. **Learn About Reconciliation:** Grow our shared understanding of what reconciliation means in this place at this time, what people/organizations are doing to advance it, and what else we can do moving forward together.
- 3. **Co-Create a Blueprint**: Dialogue about the *Draft Reconciliation Blueprint for Victoria and Area,* shaped from knowledge gathered at two previous Advisory Panel Gatherings.
- 4. **Inspire/Garner Support**: Cultivate commitment to *Draft Reconciliation Blueprint*, through strong communication tools, methodical processes and interactive facilitation.







Invitations and RSVP Deadline

The capacity for the Gathering is 300 delegates. Registration is free, but by invitation. First round invitations include the list of previous Advisory Panel participants enhanced by urban Indigenous community participants recruited through key agencies and partners.

The RSVP deadline for invitations is **Monday, February 10, 2020**. After this date, all unclaimed seats will be redistributed to other community members on the waitlist. VURD

The name Victoria Urban Reconciliation Dialogue was chosen with certain intentions but should be interpreted with the greatest scope possible. The place name **Victoria** is a geographic anchor but it is clear this conversation reaches across the South Island. The term **Urban** isn't meant to exclude on-reserve populations, just acknowledge that only Nations can guide reconciliation on reserve and we are supporting the urban spaces in between.

We encourage those living on-reserve to participate because they are the local stewards of the territory and we need that voice and perspective in all reconciliation work.

Reconciliation Blueprint

An important aspect of the Gathering will be encouraging and tracking dialogue about the *Draft Reconciliation Blueprint for Victoria and Area*. The Blueprint will outline our shared mission, values, priorities, and ways of measuring our success. It will also identify specific commitments for VURD to move reconciliation forward in Victoria and area. The goals and commitments will be based on the information gathered at the two former Advisory Panel Gatherings. It is essential we present what we heard back to the Advisory Panel members to ensure their input and perspectives are being honoured and accurately represented.
