“Intermunicipal Business Licence Agreement Authorization Bylaw, 1999, No. 2379”

The Council of the Corporation of the Township of Esquimalt, in open meeting assembled, enacts as follows:

1. The Mayor and Corporate Officer are authorized to execute and deliver the Amending Agreement - Intermunicipal Business Licence Agreement attached to and forming part of this Bylaw as Schedule “A”, which agreement is hereby adopted by adding “The District of Sooke” as a “*Participating Municipality*”.
2. That Bylaw may be cited as the “Intermunicipal Business Licence Agreement Authorization Bylaw, 1999, No. 2379, Amendment [No. 2], No.2991”.

## **Intermunicipal Business License Agreement**

Among:

The Corporation of the District of Central Saanich  
City of Colwood  
Corporation of the Township of Esquimalt  
District of Langford  
The Corporation of the District of Oak Bay  
The Corporation of the District of Saanich  
Town of Sidney  
The Corporation of the City of Victoria  
Town of View Royal  
The Corporation of the District of North Saanich  
The District of Metchosin  
The District of Highlands  
The District of Sooke

(the "Participating Municipalities")

The Participating Municipalities agree pursuant to Section 664 of the *Municipal Act* as of January 1, 2000 as follows:

1. In respect of each applicant for a license to carry on a business of any of the classes of business set out in Schedule A to this Agreement, any Participating Municipality may issue an Intermunicipal Business License.
2. A holder of an Intermunicipal Business License may, during the term of the License, carry on the business authorized by the license within the boundaries of any of the Participating Municipalities.
3. No Participating Municipality shall issue an Intermunicipal Business License in respect of any business that is not carried on from premises in that municipality.
4. Any applicant wishing to obtain an Intermunicipal Business License must make application to that municipality in which the premises of the business are located, and in the case of multiple business premises, a business license must be obtained in respect of each premises.
5. The term of the Intermunicipal Business License shall be the term of licenses issued generally for that class of business by the Participating Municipality that issues the license.
6. The minimum fee for an Intermunicipal Business License is \$100.00.
7. Each Participating Municipality shall retain for its own purposes all business license fees received in respect of Intermunicipal Business Licenses.
8. Every Intermunicipal Business License shall be issued in a unique form to be agreed from time to time by the Treasurers of the Participating Municipalities, and each of the Participating Municipalities shall issue each of the other Participating Municipalities from time to time a list of Intermunicipal Business Licenses that it has issued, and a cumulative list for the calendar year.

9. If the Council of any Participating Municipality is of the view that any holder of an Intermunicipal Business License issued by another of the Participating Municipalities has been guilty of such gross misconduct in respect of the business carried on within its boundaries that it warrants the suspension of the license, it may by resolution reciting the details of such misconduct request the Council of the Participating Municipality that issued the license to suspend it for the period specified in the resolution.

10. Any resolution made under Section 9 shall be communicated in writing to the Participating Municipality that issued the license, together with such documentary evidence of the misconduct as may be available, and the Council of the Participating Municipality shall as soon as reasonably possible consider whether the license should be suspended.

11. In making any decision as to whether to suspend a license under Section 10, the Council of each Participating Municipality shall approach the matter as if the conduct complained of had occurred within its own boundaries.

12. If a Council of a Participating Municipality has delegated to an official the authority to suspend business licenses for misconduct in respect of the business, the resolution made under Section 9 shall be communicated to the official and the official shall as soon as reasonably possible consider whether the license should be suspended in accordance with the principle set out in Section 11.

13. Nothing in this Agreement shall be construed to abridge the right of any holder of a business license to be heard by the Council or official considering whether to suspend the license.

14. Nothing in this Agreement affects the authority of the Council of a Participating Municipality to suspend or revoke any business license issued by that municipality.

15. Nothing in this Agreement limits the authority of the Council of any Participating Municipality to enact regulations in respect of any class of business under Section 679, 680 or 681 of the *Municipal Act*.

16. A Participating Municipality may, by notice in writing to each of the other Participating Municipalities, withdraw from the licencing arrangement established by this Agreement, and the notice must:

(a) set out the date on which the withdrawing municipal will no longer recognize the validity within its boundaries of business licences issued pursuant to this Agreement, which date must be at least six months from the date of the notice, and

(b) include a copy of a bylaw adopted by at least 2/3 of the members of the Council of the withdrawing municipality, authorizing the withdrawal of the municipality from the licencing arrangement established by this Agreement,

but the withdrawal of any Participating Municipality does not affect the validity within its boundaries, for the remainder of its term, of any Intermunicipal Business Licence issued prior to the effective date of the withdrawal.

**WHEREAS** the Original Participating Municipalities entered into an interim Municipal Business Licence Agreement pursuant to Section 664 of the *Municipal Act* as of January 1, 2000 (herein called "the Intermunicipal Business Licence Agreement");

**AND WHEREAS** the Highlands wishes to participate in the Intermunicipal Business Licence Agreement and the Original Participating Municipalities have agreed to allow it to do so;

**NOW THEREFORE** in consideration of the covenants and agreements contained in this agreement, the parties agree as follows:

1. The Intermunicipal Business Licence Agreement is hereby amended by adding the Highlands as a party to the agreement and by adding the Highlands to the definition of "Participating Municipalities".
2. All other conditions of the Intermunicipal Business Licence Agreement shall remain the same.




