1) <u>20-397</u> Victoria Police Department 2020 Second Quarterly Report, Chief Del Manak

Chief Del Manak, VicPD, provided an overview of the 2020 second quarter report via conference call, including community engagement efforts, crime prevention, operational updates, and emerging crime trends, presented a PowerPoint Presentation, and together with Inspector Keith Lidner and Director Mark Macintyre, VicPD, responded to questions from COTW.

COTW comments included importance of reinstating the school liaison officer position for 2020, statistical data and graphs within the report and ensuring transparency with numerical data, tracking benefits of the new communications strategy, complexities of policing services providing service to two communities differing communities.

Chief Del Manak informed Council that Statistics Canada has responded to Esquimalt's request for separating crime statistics from Victoria and that the data will be provided separately for 2020 and moving forward. He further informed COTW that he would provide the missing data on the second quarter cross over calls.
