#### 6. STAFF REPORTS

#### Administration

1) <u>21-116</u> Update of Strategic Priorities and Operational Strategies 2021, Staff Report No. ADM-21-006

CAO provided an overview of the report and together with the Director of Community Safety Services and Director of Development Services responded to questions from Council.

Mayor Desjardins requested that an item in the Operational Strategies document be removed under the heading "Control deer in partnership with other governments" as follows:

"advocate for a region wide strategy with the CRD"

The CRD Board has confirmed that no further action will be taken on this initiative at this time.

Moved by Councillor by Councillor That Brame, seconded Helliwell: Council approve the updated Strategic **Priorities** 2019-2023 and Operational Strategies as presented in Staff Report No. ADM-21-006. Carried Unanimously.

## **Community Safety Services**

2) <u>21-085</u> Community Emergency Preparedness Fund; Emergency Support Services Stream - Grant Application, Staff Report No. CSS-21-003

Moved by Councillor Brame, seconded by Councillor Helliwell: That Council support by way of resolution a \$15,980.00 application for the Community Emergency Preparedness Fund - Emergency Support Services Stream and authorize the Mayor and Corporate Officer to execute any agreements related to a successful grant application, as outlined in Staff Report No. CSS-21-003. Carried Unanimously.

3) <u>21-086</u> Recommendation for Contract Award - Construction Management Services for Public Safety Building, Staff Report No. CSS-21-004

Director of Community Safety Services provided an overview the report including the history of events leading to the Public Safety Building project such as funding streams, feasibility study, and public consultation as well as upcoming key milestones associated with the project such as an alternate approval process and funding timelines.

Council comments included time, costs, land agreements, and noise impact as the rationale for not providing housing in the redevelopment.

Staff responded to questions from Council.

Moved by Councillor Brame, seconded by Councillor Helliwell: That Council award Kinetic Construction Ltd., the contract for Construction Management Services for the Public Safety Building [PSB] and direct staff to finalize the Professional Services Agreement, as outlined in Staff Report No. CSS-21-004. Carried Unanimously.

4) 21-120 Request for inclusion of IRM/Gasification Initiative in CRD Solid Waste Master Plan, Staff Report No. EPW-21-006

Director of Engineering & Public Works attended the meeting via conference call at 7:25 PM to provide an overview of the report.

Council comments included importance of recognizing Integrated Resource Management/Gasification as an option for regional waste management strategies.

Moved by Councillor Hundleby, seconded by Councillor Helliwell: That Council direct staff to contact the Capital Regional District to request that a section regarding Integrated Resource Management/Gasification be included in the submission of the draft Solid Waste Master Plan, as outlined in Staff Report No. EPW-21-006. Carried Unanimously.

## **Development Services**

5) <u>21-079</u> Detached Accessory Dwelling Unit Bylaw Amendments, Staff Report No. DEV-21-003

Planner attended the meeting via conference call at 7:32 PM, provided an overview of the report, presented a PowerPoint Presentation, and together with the Director of Development Services responded to questions from Council.

Council comments included increasing housing options in the community and creative solutions for parking options.

Moved by Councillor Morrison, seconded by Councillor Brame: That Council give first reading to Zoning Bylaw, 1992, No. 2050 And Parking Bylaw, No. 2011, 1992, Amendment Bylaw No. 3013, 2021, which would allow for the regulation of Detached Accessory Dwelling Units (DADUs) in specific areas of the Township and further, that Council authorize staff to distribute notices to all affected property owners outlining the proposed amendments. Carried Unanimously.

6) <u>21-083</u> Development Variance Permit - 1151 Esquimalt Road (Archie Browning Sports Centre - signage), Staff Report No.: DEV-21-009

Director of Development Services provided an overview of the requirements for Council approval.

Director of Parks & Recreation Services joined the meeting via conference call at 7:58 PM, provided an overview of the application including a review by the Parks & Recreation Advisory Committee to develop operating guidelines

for use of the sign to mitigate distraction impact to neighbors and traffic.

Brock Abel, Graphic FX Signworks, joined the meeting via conference call at 7:58 PM, presented a PowerPoint Presentation detailing the sign placement and design, and together with staff responded to questions from Council.

Council comments included options to increase traffic safety near the plaza and whether the signage could be functional at a reduced size.

Moved by Councillor Brame, seconded by Councillor Vermeulen: That Council resolves that Development Variance Permit No. DVP00107 [Appendix A of staff report DEV-21-009] authorizing a new freestanding sign with animated video display, to be located adjacent to the Esquimalt Road entrance to the Archie Browning Sports Centre, consistent with the plans provided by Graphic FX Signworks stamped "Received January 12, 2021", the landscape plan provided by Esquimalt Parks staff stamped "Received August 7, 2020", located as shown on the BCLS Site Plan provided by Wey Mayenburg Land Surveying Inc. stamped "Received September 14, 2020", and to be operated according to the "Operating Guidelines" provided by Esquimalt Recreation staff stamped "Received January 13, 2021; including the following variances be approved, and staff be directed to issue the permit and register the notice on the title of the property 1151 Esquimalt Road [PID 001-114-239; Lot 1, Section Esquimalt District, Plan 14686];

Vary Sign Regulation Bylaw, 1996, No. 2252, Part 6 - Prohibitions - to allow the Freestanding Sign to occasionally have third-party advertising (for community event related advertisers) and therefore, act as a billboard

Vary Sign Regulation Bylaw, 1996, No. 2252, Part 7 - General Provisions - Section 9.8.1 - to allow the Freestanding Sign to be located on a property frontage of less than 30 metres (i.e., property has a 7.62 metre frontage on Esquimalt Road)

Vary Sign Regulation Bylaw, 1996, No. 2252, Part 7 - General Provisions - Section 9.8.2 (a) - to allow the Freestanding Sign to be located within 20 metres of a residential zoned property (i.e., from 30 metres to 20 metres)

Vary Sign Regulation Bylaw, 1996, No. 2252, Part 7 - General Provisions - Section 9.8.2 (b) - to allow a Freestanding Sign to be located 1.4 metres from a property line (i.e., from 2.0 metres to 1.4 metres)

Vary Sign Regulation Bylaw, 1996, No. 2252, Part 7 - General Provisions - Section 9.8.2 (c) - to allow the Freestanding Sign to be larger than the landscaped area in which it sits. (i.e., sign area of 30.54 m2 and landscaped area of 29.95 m2)

Vary Sign Regulation Bylaw, 1996, No. 2252, Part 7 - General Provisions - Section 9.8.3 (b) - to allow the area of the Freestanding Sign to be greater than 20 square metres (i.e., from 20 m2 to 30.52 m2). Carried.
