The school hopes beyond that to evaluated the first three sessions and explore establishing an ongoing relationship involving the use of the Gorge Pavilion for Peace Education.

GVPS is a non-profit voluntary association. We are an official project of Nonviolence International Canada, a registered charity. We are funded entirely through individual donations. The school recently completed its inaugural term in which students were able to explore a positive vision of how our communities and the world could be and practical steps all of us can take to advance the cause of peace.
