## Re: Implementation of Service Priorities for Transit Routes 24, 40 and 46

At the Council meeting held February 21, 2023, View Royal Council was in receipt of the attached notice of motion from Councillor Rogers requesting that BC Transit proceed in 2024 with the implementation of three proposals outlined in BC Transit's 2021 *Esquimalt-View Royal Local Area Transit Plan*. The specific proposals for advancement include the short-term service priorities of Route 24 realignment (Admirals Walk/Cedar Hill) and Route 40 introduction (UVic to Dockyard via Admirals-McKenzie) as well as the medium-term priority of Route 46 expansion (Dockyard/Westhills).

Routes 24 and 40 were described in the public engagement component of the *Esquimalt-View Royal Local Area Transit Plan* as "almost universal wins" for the communities. As well, the proposal to expand Route 46 received strong public support. These routes will address gaps in service and enhance the integrity of the transit network serving all of our communities.

After some discussion, Council passed a resolution that will see the Town write to BC Transit requesting that they implement the above-described service priorities beginning in 2024. As well, View Royal Council wanted to ask the Esquimalt Nation, Songhees Nation, Township of Esquimalt and District of Saanich to be joint signatories on this letter to BC Transit given the importance of the transit service and these potential improvements to all our communities.

#### **BACKGROUND**

# Page 29 of Active Transportation Plan: Baseline Conditions Report states...

BC Transit Esquimalt-View Royal Local Area Transit Plan (2021)

This plan builds upon the 25-year vision for development of the Victoria Regional Transit System identified in the 2011 Transit Future Plan. It provides specific transit network modifications, service level changes and infrastructure improvements to support the development of the transit network within the Township of Esquimalt, the Songhees Nation, the Esquimalt Nation, and the Town of View Royal. <a href="https://www.bctransit.com">https://www.bctransit.com</a> documents > 1529711822375

While the plan is focused on transit related improvements, it recognizes the important connection between transit and active transportation. The plan indicates that all active transportation infrastructure recommendations need to consider the potential impacts on transit service delivery.

### **SHORT TERM SERVICE PRIORITIES: #40, 24, 46**

Given these routes significantly address ridership needs and support economic development for View Royal, Esquimalt, Songhees Nation, Esquimalt Nation, and Saanich, we call upon Victoria Transit to implement these starting in 2024.

# The report descriptions / maps for the three routes.

# 4.1 Short Term Service Priorities

During the second phase of engagement, three service proposals were clearly identified as almost universal wins for the communities within the plan areas. These proposals effectively address gaps in service and enhance the integrity of the transit network serving the Esquimalt and View Royal area.

#### Proposal 1: New Route 40 UVic to Dockyard via Admirals-McKenzie

This proposed route services the entire length of the east-west Admirals and McKenzie corridor from CFB Esquimalt - Dockyard to the University of Victoria. This route is ultimately identified for development into a Frequent Transit Network route, but would initially be introduced with a basic level of service – perhaps only at peak commute times.




Figure 6: Proposed routing for new service along Admirals and McKenzie from Dockyard to UVic.

#### **Benefits**

- The route would provide direct access to UVic from Esquimalt and provide additional service on McKenzie – a high volume transit corridor.
- The route would provide more direct and convenient access along Admirals Road to popular destinations including CFB Esquimalt and Admirals Walk Shopping Centre.
- The route would provide more direct connections for passengers traveling from the West Shore to either UVic or CFB Esquimalt.

#### Considerations

- Congestion at Craigflower Road, Highway 1, Pay Bay Highway and Shelbourne Street may impact reliability and on-time performance.
- Investment is required to construct bus stops along the Saanich portion of Admirals Road from Craigflower Road to Burnside Road.
- This rerouting can coincide with terminating the route 25 Admirals Walk at Dockyard to reduce duplication of service along Admirals Road.




Figure 7: Proposed modification of route 24 to terminate at Tillicum Mall via Cowper and Obed.




Figure 10: Map of existing service on route 46.




Figure 1: Geographic area and existing transit network of Esquimalt-View Royal.

We write to you today requesting the implementation of service priorities for Routes 24, 40 and 46 beginning in 2024.

These routes are detailed in BC Transit's 2021 *Esquimalt-View Royal Local Area Transit Plan* as being short-term (Routes 24 and 40) and medium-term (Route 46) service priorities. Short-term service priorities were identified through public engagement as "almost universal wins" within the Plan areas and the medium-term service priority received strong support. While the *Esquimalt-View Royal Local Area Transit Plan* is focused on transit related improvements, it also recognizes the important connection between transit and active transportation.
