Dear Marlene,

I met you recently at Earth Day in Highrock Park. I will not be able to attend to your forum.

On the other hand, I hope that you will take into account and consider Victoria Harbour Bird Sanctuary in your planning exercise.

Your Park Manager, Rick Daykin, is already quite engaged and aware through the Gorge Waterway Initiative, where I met him in 2015.

This historic Migratory Bird Sanctuary, one of three in Greater Victoria with Esquimalt Lagoon and Shoal Harbour, was established to control hunting, particularly the market hunting of Pacific Brant, nearly 100 years ago. It was the first Migratory Bird Sanctuary established on the Pacific coast of Canada.

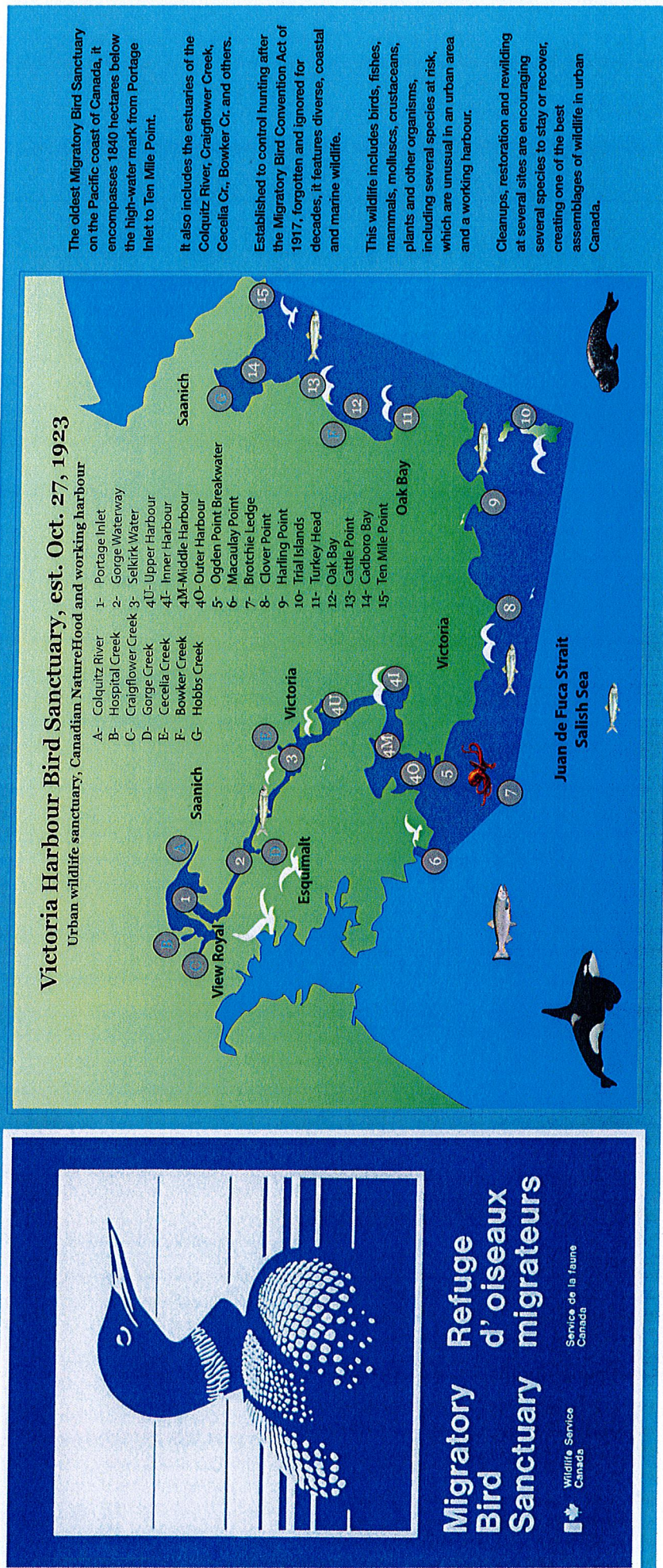
Today, it harbours valued, valuable and remarkable urban wildlife, including birds, mammals, fishes and molluscs, etc. such as Buffleheads, Pacific Harbour Seals, Pacific Herring and Olympia Oysters. This is why Nature Canada recognized it as a Canadian NatureHood a few months ago. NatureHoods are meant to connect urban Canadians and their children to nature.

Please note that Victoria Harbour, Esquimalt Harbour and the Gorge Waterway have not been this clean in half a century thanks to the efforts of countless volunteers, NGOs, private enterprises and government agencies (municipal, CRD, provincial and federal). It appears that something like \$500 M have already been spent to do this over the last decades. A huge success of national significance. As a result, wildlife is staying and coming back.

In fact, Greater Victoria is now considered to have the best coastal and marine wildlife in urban Canada. This is a big story that I will be glad to discuss with you at one point, from oak trees to Olympia Oysters and Pacific Herring.

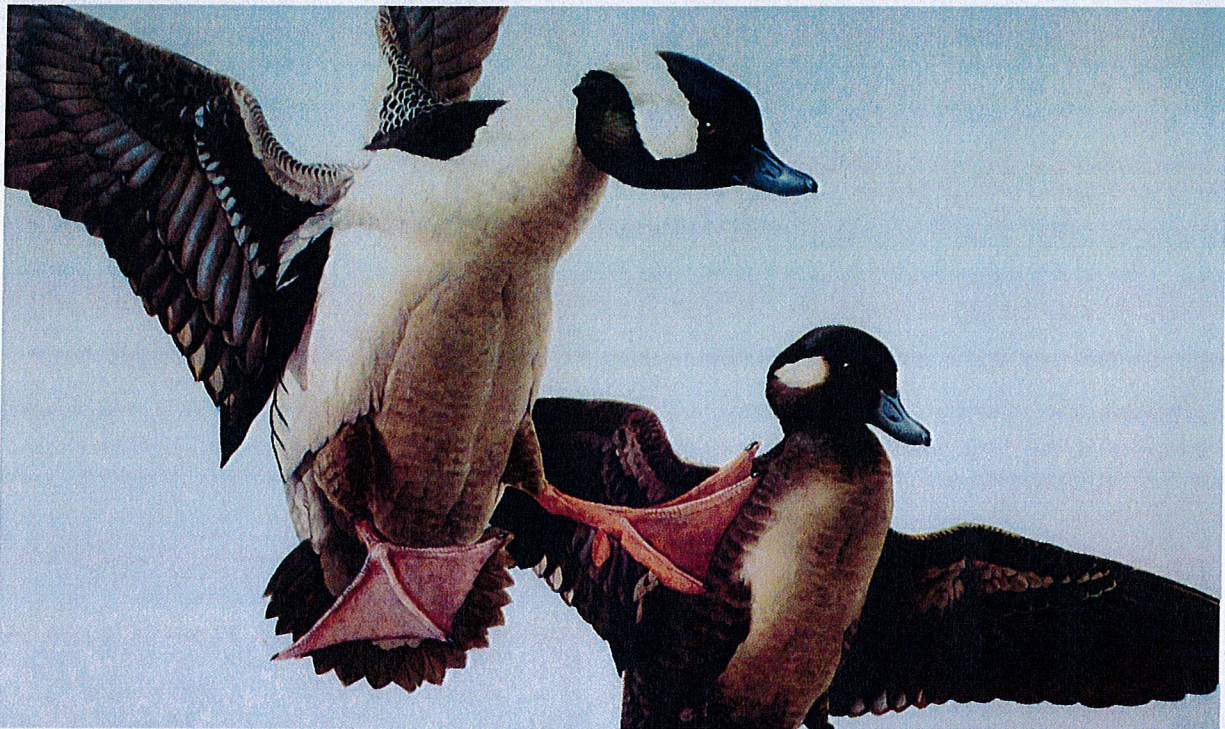


VICTORIA HARBOUR MIGRATORY BIRD SANCTUARY

A common wintering duck in and near the entire sanctuary, from Portage Inlet to Ten Mile Point. In Victoria Harbour, 300 to 400 may winter in West Bay alone. Known for being punctual, it usually begins to return to Greater Victoria by Oct. 15, "All Buffleheads Day", the 298th day of the solar year. In 2015, one female arrived in Shoal Harbour Migratory Bird Sanctuary (Sidney) on that day when one male and nine females were also reported at Esquimalt Lagoon Migratory Bird Sanctuary. No Bufflehead was detected in Victoria Harbour Migratory Bird Sanctuary until Oct. 21, with two males and four females in Oak Bay near Bowker Creek, and a group of 30-40 on Portage Inlet near Colquitz Creek, on Oct. 25.

Saanich Parks needs to step up and protect the wildlife in the Colquitz estuary, Portage Inlet and Cuthbert Holmes Park.

View Royal needs to protect the wildlife in the Craigflower creek estuary, and Portage Inlet. And stop encouraging wildlife disturbances in their area, where boaters then find their way up the Colquitz estuary.

Your Honour: I've just read an article about the discussion about a community plan vision statement. I'm sharing a word of caution about some language in the chosen statement.

I would not advise the municipality to make a statement that may be perceived as a reference to "our" First Nations. As an Indigenous person I do not like to be referred to in the possessive by "settler" governments and I expect that this is the case with Songhees and Esquimalt Nations. It may work better to say "Esquimalt is a caring and welcoming community that has strong relationships with our neighbours, the Songhees and Esquimalt Nations (or First Nations but check with them first), regional municipalities, and the naval base."

Please accept this message as a gesture of friendship and respect, as it is intended.

I'm writing as a resident of Esquimalt municipality, as an Indigenous (Anishinaabe) person, and as one who honours the Lkwungen people on whose traditional territories we live and work.
