Director of Engineering and Public Works responded to questions from Council.

1. Grant early budget approval of \$2,813,000 for the Esquimalt Town Square Remediation Project in the 2017-2021 Financial Plan;
2. Direct Staff to prepare a bylaw to initiate the transfer of \$2,813,000 from the Infrastructure and Revitalization Reserve Fund to the Capital Project Reserve Fund; and
3. Approve the awarding of the Esquimalt Town Square Remediation Project at a cost of \$2,222,512.94 to Tervita
4. Conditional on receipt of documentation from Tervita, pertaining to the tonnage amount and disposal of all soil. Carried Unanimously.

- 4) [17-099](#) Traffic Order 1241 - Rockheights Ave and Hutchinson Ave/Hutchinson Pl, Staff Report EPW-17-007

Director of Engineering and Public Works responded to questions from Council.

Moved by Councillor Hundleby, seconded by Councillor Brame: That Council approve Traffic Order 1241 that existing "Yield" signs on Hutchinson Avenue at Rockheights Avenue and Hutchinson Place at Rockheights Avenue be replaced with "Stop" signs and road markings at the same locations, and rescind Traffic Orders 399 and 536. Carried Unanimously.
