Moved by Councillor Liberchuk, seconded by Councillor Brame: That Council resolves that Development Variance Permit No. DVP00058 [Appendix A] authorizing the development as shown on the plans, stamped "Received January 31, 2017", and sited as detailed on the survey plan prepared by Powell and Associates, BCLS stamped "Received January 31, 2017", and including the following relaxations to Zoning Bylaw, 1992, No. 2050, be approved, and staff be directed to issue the permit and register the notice on the title of the property located at PID 017-444-837, Lot A, Section 11, Esquimalt District, Plan VIP52814 [1036 Munro Street]:

Zoning Bylaw, 1992, No. 2050, Section 34(9)(b)(ii) - Side Setback: a 2.98 metre reduction to the required 3.6 metre side setback from an exterior side lot line [i.e. from 3.6 metres to 0.62 metres];

Zoning Bylaw, 1992, No. 2050, Section 34(9)(b)(iv) - Building Separation: a 1.1 metre reduction to the required 2.5 metre separation between a principal building and an accessory building [i.e. from 2.5 metres to 1.4 metres]. Carried Unanimously.

12. RISE AND REPORT

Mayor Desjardins read the following motion passed on March 20, 2017 at the In Camera meeting of Council.

Whereas the Township of Esquimalt has received an application from the owner of 101 Island Highway to rezone the property from Tourist Commercial [C-5A] to a site specific Comprehensive Development District in order to allow the property to be used for a mixed commercial - residential rental project; and

Whereas the owner has submitted a reference plan to the BC Land Titles Office that would allow for the incorporation of a small amount of additional land along the Gorge Waterway that is currently not included in the existing parcel (shown in red on the attached plan) (herein referred to as the Additional Lands); and

Whereas it is anticipated that the new reference plan will be registered in the next three months, which would incorporate the Additional Lands into the parcel of the owner;

Now therefore Council authorizes the rezoning application of the Additional Lands and the balance of the owner's parcel at the same time to the same Comprehensive Development District.
