4.		CONSIDERATION OF 2017 - 2021 SUPPLEMENTAL OPERATING AND CAPITAL REQUESTS AND FUNDING			
	Supple Power scena	Director of Financial Services and IT provided an overview of 2017-2021 Supplemental Operating and Capital requests and funding, presented a PowerPoint presentation and responded to questions from Council. All scenarios presented result in surplus amounts ranging from \$712,501 to \$186,589 based on a tax rate between 0% and 1.90% increase. Tax Rate			

scenarios will be presented on April 3, 2017 for Council consideration.

Council comments included (Staff response in italics):

* Suggested inclusion of budget cost for installation of lighted crosswalk on Esquimalt Road near Renaissance Seniors Residence, staff to review cost and funding options

* Unsightly Property demolition process and expense

* Memorial Park as venue for Esquimalt Farmers Market, consider Portable Washrooms to be located in park during Summer months

* Increased patrol for Animal control and staff resources for monitoring

- * Encouraged Walking Tours to be available on App
- * Increased Water Park washroom cleaning during Summer
- * Park landscape maintenance
- * Interim vehicle rental for Recreation services

* Request for staffing increase to assist with asset management plan, succession planning and cross training

* Technology replacement and software implementation processes

* Municipal float replacement and RFP process, with input from Lions Club

- * Municipal Hall stairwell repairs
- * Maintenance of roads including pothole filling
- * West Bay Walkway Realignment

* Recreation Parking lot overlay and challenges of temporary closure with minimal impact

- * Electronic signage at Recreation Centre
- * Mulch Storage containers for in-house processing

Moved by Councillor Brame, seconded by Councillor Burton-Krahn: That an additional \$50,000 be included in the 2017 budget for pothole road maintenance. Carried.

- In Favour: 3 Councillor Brame, Councillor Burton-Krahn, and Councillor Liberchuk
- Opposed: 2 Mayor Desjardins, and Councillor Low

Absent: 2 - Councillor Hundleby, and Councillor Morrison

Moved by Councillor Brame, seconded by Mayor Desjardins: That Council direct staff to 1) prepare a 1.0% Tax Rate increase scenario, including allocation of funds for portable washrooms at Memorial Park, additional \$50,000 for Pothole Maintenance and installation of lighted crosswalk on Esquimalt Road, 2) with surplus funds allocated to a Reserve Account for the Esquimalt Town Square Project, for Council consideration.

Council agreed to separate the motion into 1) tax rates and 2) surplus.

Moved by Councillor Low, seconded by Councillor Brame: That the Main Motion be amended to include scenarios for a 0% and 0.5% Tax Rate increase. Carried Unanimously.

The vote was taken on the Main Motion as amended and declared Carried Unanimously.

Moved by Councillor Brame, seconded by Mayor Desjardins: That Council approve any surplus funds be allocated into a Reserve Account for the Esquimalt Town Square Project. Defeated.

In Favour: 1 - Councillor Brame

- Opposed: 4 Mayor Desjardins, Councillor Burton-Krahn, Councillor Liberchuk, and Councillor Low
- Absent: 2 Councillor Hundleby, and Councillor Morrison

Moved by Councillor Low, seconded by Councillor Burton-Krahn: That any surplus amount be allocated to an accumulated surplus account for future use. Carried Unanimously.

Mayor Desjardins called three times for public input and there was none.

Moved by Councillor Burton-Krahn, seconded by Councillor Low: That the Special Council meeting be adjourned at 6:54 PM. Carried Unanimously.
