#### Finance

1) 17-225 Asset Management Policy, Staff Report FIN-17-011

Director of Financial Services provided an overview of the first stage towards Asset Management Plan and responded to questions from Council.

Chief Administrative Officer responded to questions from Council.

Council comments included:

- \* Clarity of natural assets
- \* Staff resources and timelines
- \* Incorporate environmental, social and economic concerns into process and plan

Moved by Councillor Hundleby, seconded by Councillor Brame: That the COTW receive Staff Report No. FIN-17-011 for information, provide any direction to staff regarding the draft Asset Management Policy, and direct staff to prepare a report for Council's consideration. Carried Unanimously.

# **Engineering and Public Works**

2) <u>17-249</u> Vehicle and Bicycle Interaction at Intervale Avenue E&N Rail Trail Crossing, Staff Report EPW-17-027

Director of Engineering and Public Works responded to questions from Council.

Comments from Council included:

- \* Not in support of road closure and concerns with impact on neighbours
- \* Install stop signs for cyclists
- \* Concerns with community safety
- \* Homeowners hedge impedes onto trail and impacts sightlines of cyclists and motorists
- \* Council requested statistics of trail users
- \* Council inquired whether the railway would be in operation again the the future
- \* Council suggested a Town Hall meeting to seek public input re: road closure

Moved by Councillor Brame, seconded by Councillor Low: That the COTW receive Staff Report EPW-17-027 for information, and direct staff to install stop signs for cyclists on the E & N Rail Crossing Trail at Intervale Avenue. Carried Unanimously.

#### **Development Services**

3) <u>17-248</u> Affordable Housing Workshop Summary Report, Staff Report DEV-17-036

Community Development Coordinator provided an overview of the Affordable

Housing Workshop held at the Archie Browning Sports Centre, Esquimalt on May 5th, 2017, presented a PowerPoint Presentation and responded to questions from Council. Affordable Housing has formed part of the Official Community Plan review, which is currently in phase 5.

Comments from Council included:

- \* Community engagement re:Tiny Home designated site options
- \* Availability of rental properties that allow pets; limited units triggering higher rental fees and deposits
- \* Encouraging developers to construct family friendly condo's with at least 3 bedrooms
- \* Secondary suite statistics
- \* Carriage House options
- \* Opposed to an additional Housing Trust, as one already in palce through the Capital Regional District Council requested further information
- \* Need a Regional Collaboration.
- \* Green space should be preserved
- \* CRD Regional Housing First Program Council suggested a Presentation to provide further information
- \* Public input from apartment tenants and condo owners; suggested a survey
- \* Compare other Municipal Housing Policies and Bylaws encouraging affordable housing
- \* Transportation options
- \* Greater Victoria Coalition to End Homelessness; referred to report on Housing and Supports

Moved by Councillor Hundleby, seconded by Councillor Liberchuk: That Council recess the Regular Committee of the Whole meeting. Carried Unanimously.

The meeting recessed at 6:55 PM and reconvened at 7:22 PM with all members of Council present, except Councillor Morrison.

Council continued discussion on the Affordable Housing Workshop Summary Report, Staff Report DEV-17-036.

Moved by Councillor Burton-Krahn, seconded by Councillor Liberchuk: That the Committee of the Whole receive Staff Report No. DEV-17-036 for information, provide direction to staff on whether to proceed with further engagement opportunities, and direct staff to draft new policies for the Official Community Plan based on the findings from the affordable housing workshop. Carried Unanimously.
