#### 6. STAFF REPORTS

#### Administration

1) <u>17-413</u> Capital Integrated Services & Governance Initiative, Staff Report ADM-17-022

CAO suggested Council consider using the the Workbook: Evaluating Opportunities for Service Integration, as a guide for discussion and in preparation for budget and Strategic Planning and responded to questions from Council. CAO advised Council comments will come back for further discussion and items will be bought forward during budget discussion.

Comments and areas of focus from Council included:

- \* Initiating a Mayors' focus group to address integrated services and focus on a proposed plan and work towards a common goal
- \* Consider services offered between Core and Regional areas and who can benefit from integration
- \* Standardize solid waste management services based on cost
- \* Introduce further integrated bicycle lanes
- \* Suggested using a program similar to BIZPAL as a shared centralized place to find information and apply for licences and permits
- \* Policing costs relating to services used by all Municipalities, particularly in the downtown Core
- \* Shared regional transportation services including BC Transit
- \* Not in favour of funding services that Esquimalt residents do not utilize
- \* One pass for all recreation centres versus service for solely Esquimalt residents suggested tracking Esquimalt residents who buy a pass to use at other centres in the region
- \* Include First Nations in future discussions
- \* Shared water services
- \* Standardize Building Code Bylaw, inspection services and interpretation between Municipalities in preparation for the Building Step Code implementation
- \* Integrate current library systems and provide the same services for all
- \* Consider shared fire services with City of Victoria if cost effective
- \* Consider integrated storm water management services with City of Victoria, as water services are already shared
- \* Consider shared Bylaw enforcement services outside of business hours
