Miriam Booker, *resident*, in support of development and addressed parking sightline concerns.

Andrew Gates, *resident*, expressed concerns pertaining to cost, sightlines and history of the church should rezoning be approved.

Sherri Robinson, *resident*, suggested Ministry Centre stand on its own land parcel and not with church.

Lynn Schumacher, *non-resident*, in support of rezoning application with new accessible washrooms.

Lee Morrow, *resident*, in support of development however, expressed concerns regarding impact to tax base.

Sue Donaldson, *resident*, expressed concerns that Council are being rushed to make a decision.

Bob Randal, *non-resident*, suggested an alternative opportunity for Council consideration and suggested the decision be made after the Election with new Council.

Merrel Wall, *non-resident*, in support of development and senior social housing.

John Ducker, *resident*, in support of rezoning application and advised the church needs a new business model to financially move forward.

Stuart Stark, *non-resident*, expressed concerns regarding the amendment to Official Community Plan and change in designation to the church.

Sharon Wickware, *non-resident*, in support of rezoning application and proposed development which will allow the church to continue as a viable part of the Community.

Helen Cave, *resident*, in support of rezoning application.

Doug Scott, *resident*, in support of rezoning application.

Tom Mercer, *non-resident*, expressed concerns regarding alteration to the stained glass windows in the church.

Cameron Bailey, *resident*, expressed further parking concerns.

John Ducker, *resident*, expressed further financial concerns for church if rezoning is denied.

Lee Morrow, *resident*, expressed further tax concerns if rezoning approved.

Helen Cave, *resident*, suggested low income residents may not have vehicles therefore will not occupy parking spaces.

Sue Donaldson, *resident*, expressed concerns with the loss of the Heritage Designation Bylaw should rezoning be approved.

Miriam Booker, *resident*, suggested church building is in need of an upgrade.

Darwin Robinson, *resident*, encouraged Council to deny application and allow the applicant to return with a new plans addressing sightlines.

No. 2050 by changing Comprehensive Development District No. 23 [CD No. 23] (the existing zoning designation) of 1379 Esquimalt Road / 520 Foster Street, [PID 024-848-905; Lot A (DD EP75276), Suburban Lot 27, Esquimalt District, Plan 5092] shown cross-hatched on Schedule 'A', to accommodate a new ministry centre with twenty-four (24) residential units above be given third reading; and

WHEREAS: The Road Safety Law Reform Group of British Columbia and organizations including the City of Vancouver, the City of Victoria, the British Columbia Cycling Coalition and Trial Lawyers Association of British Columbia have called on the Government of British Columbia to review and modernize the BC Motor Vehicle Act;

AND WHEREAS: Modernization of this legislation is necessary to achieve the Government of British Columbia's "Vision Zero" plan to make BC's roads the safest in North America and eliminate road-related injuries and deaths by 2020;

AND WHEREAS: the Road Safety Law Reform Group has provided

evidence-based recommendations for increasing safety for vulnerable road users, including children, seniors, people with disabilities, pedestrians and cyclists;

THEREFORE BE IT RESOLVED: that the Government of British Columbia review and modernize the BC Motor Vehicle Act, to increase safety for all road users and achieve the "Vision Zero" objective of making BC's roads the safest in North America and eliminating road-related injuries and deaths by 2020.

AND THEREFORE BE IT FURTHER RESOLVED: THAT Council (1) endorse the Road

Safety Law Reform Group of British Columbia's Position Paper on Modernizing the BC
