1) <u>18-513</u> Presentation of Spirit Award and Mayor's Medallion Mayor Desjardins presented the Volunteer Spirit Award to Bryan Mee, who voluntarily performs above and beyond normal expectations and is motivated simply by the accomplishment of the task. The acts worthy of recognition must directly benefit the community of Esquimalt.

Mayor Desjardins presented the Mayors' Medallion Award to Dr. James Laing. The Mayors' Medallion is the highest possible recognition from the Township and recognizes an individual whose service or achievement at the local, provincial, national or international level has been of singular significance.

2) <u>18-514</u> Tina O'Keeffe, Esquimalt Atom Smashers (Robotics Team), Re: Club Update

Tina O'Keeffe, Esquimalt High School teacher and mentor, provided an overview of the school's Robotics Team, Esquimalt Atom Smashers, and presented a PowerPoint Presentation. The Team won the Regional 2018 "All Star Rookie" Award, which enabled them to compete in Houston, Texas. The students overcame obstacles, raised \$35, 000 in three weeks and finished 45 / 67 in their league. Esquimalt High School now offers a robotics class and continues to engage the community with their work. Ms. O'Keeffe invited Council to the Celebration of Learning event at the school on January 16th, 2019, from 4:30 PM to 6:00 PM.

Director of Engineering and Public Works responded to questions from Council and explained the intent of the 30 minute time limit was to balance the parking on this street.

Development Services

5) <u>18-497</u> Official Community Plan Amendment Consultation, 636 and 640 Drake Avenue, Staff Report DEV-18-085

Director of Development Services provided an overview of public input process and responded to questions from Council. He advised the proposal has already been presented to the Advisory Planning Commission and APC Design Review Committee. The proposed development for 636 and 640 Drake Avenue, will be

brought to Council for consideration of first and second readings of Bylaws in February and upon approval by Council, will proceed to Public Hearing in March/April, 2019.

Previously designated housing units for veterans have been replaced with memory care housing units and primarily for housing residents 55 years and older.
