Community Safety Services

20-401 Deer Study Proposal, Staff Report No. CSS-20-014
Director of Community Safety Services responded to questions from Council.

Council comments included:

- * Concerns associated with the timing of the deer management proposal and the current impact of the COVID-19 pandemic.
- * Various options for deer management and funding availability for certain deer management options including consideration of public consultation to determine support for the cost associated with this method of management.
- * Partnering with DND, neighbouring municipalities, and First Nations for a collaborative approach.

Lisa Trotter, Senior Manager - Government Relations, Seth Wright, Transit Planner, and Levi Megenbir, Senior Planner Work Lead, BC Transit attended via conference call and provided an update on BC Transit services and the Esquimalt-View Royal local area transit plan, presented a PowerPoint

Presentation, and responded to questions from Council. Highlights and discussion included impact and response to the COVID pandemic, transit planning and local route context, public consultation, future planning and updates to routes servicing Esquimalt, and next steps for the service.

Parks and Recreation

2) 20-406 Contract Award: Construction Services for Esquimalt Gorge Park, McLoughlin Point Amenity Funds - Waterfront Parks Project, Staff Report No. P&R-20-004

Director of Parks and Recreation provided an update on the Esquimalt Gorge Park Project and staff responded to questions from Council.

Council comments included consideration of funding availability for other projects and providing clarification to the public on the decision to prioritize the multi-purpose building project at Esquimalt Gorge Park.

Moved by Councillor Brame, seconded by Mayor Desjardins: That Council:

- a. award Knappett Construction Inc the contract for construction of the multi-purpose building project at Esquimalt Gorge Park and direct staff to finalize the construction contract details; and,
- b. direct staff to request approval from the Capital Regional District for the transfer of more than 20% of the funds from the McLoughlin Point Amenity
- Recreation Improvements Reserve Fund to the McLoughlin Point Amenity Waterfront Parks Reserve Fund that are required for the project and the remainder of funds be transferred to the Public Safety Building project; and,
- c. should the Capital Regional District not permit the transfer of more than 20% of the McLoughlin Point Amenity Funds, direct staff to transfer 20% of the funds from the Recreation Improvements Reserve Fund to the Waterfront Parks Reserve Fund (\$1,000,000) and enter into long-term borrowing for the remaining funds required for the project (\$1,909,437)
- d. direct staff to actively apply for and pursue any applicable grant funding opportunities in order to reduce the amount of funds necessary from long-term borrowing. Carried Unanimously.
