1) <u>21-500</u> Minutes of the Regular Committee of the Whole meeting held August 23, 2021

Finance

1) <u>21-490</u> Local Grant Policy, Staff Report FIN-21-017

Director of Financial Services responded to questions from Council.

Council comments included:

- * Pros and cons of multi-year funding for established events.
- * Consideration of implementing a scoring matrix to utilize when evaluating local grant applications to increase transparency.
- * Options to minimize overspending of in-kind support by organizations.
- * Encouraging grant recipients to provide Council with an update on the funded initiatives.
- * Implementing a regular review of the policy to ensure the objectives are being met.

2) <u>21-457</u> Deer Fencing, Staff Report No. DEV-21-070

Director of Development Services responded to questions from Council

Council comments included:

- * Deer study currently underway and determining its success prior to addressing issues further.
- * Impact of urban deer on food security and practices of other municipalities.
- * Options for fence configurations to minimize deer issues while maintaining form and character of neighbourhoods and development of design quidelines.
- * Processes for fence variances and ensuring a fair and consistent approach to compliance.

3) <u>21-503</u> Banner holder program, Staff Report EPW-21-23

Director of Engineering and Public Works responded to questions from Council and comments included cost saving considerations, options for rotation and design, benefits of the banner program on the community, and consideration of recycling initiatives for current banners in useable condition.

4) <u>21-504</u> Inflow and Infiltration Funding Strategy, EPW-21-022 Staff responded to questions from Council.

Council comments included:

- * Consideration of funding approaches including a parcel tax increase or individual area increases and a Alternate Approval Process or referendum.
- * Impact of the Department of National Defense's efforts to resolve inflow and infiltration issues.
- * Benefits of reduced flow on the community as a whole.
- * Development of a hybird approach utilizing the parcel tax option and long-term borrowing.
