STRATEGIC RELEVANCE:

This Request for Decision does not directly relate to any specific Council priority.

BACKGROUND:

The Township is in receipt of Municipal Notice from the Passenger Transportation Board (PTB) related to an application for a local taxi company to provide service within Esquimalt and the Capital Regional District (Attachment 1). The PTB is requesting comments within 30 days of the receipt of

the Notice (by February 26, 2022) to be able to consider the Township's comments prior to making a decision on the application from Brian Foley, operating as Bluebird Cabs.

ISSUES:

1. Rationale for Selected Option

The applicant is requesting approval to provide a new taxi service with a fleet size of one conventional taxi servicing the Capital Regional District area. Details of the application are set out in the attached Notice (Attachment 1).

2. Organizational Implications

There are no organizational implications with this Request for Decision.

3. Financial Implications
